

# Texas State Forest Festival VENDOR Agreement

(may set up Tuesday from 9-5)

Booths must be ready by 4:00 p.m.  
Wednesday, September 22, 2010  
**\* NO EXCEPTIONS!**

### PRICE:

**\$125 Single (10'x10' booth)  
\$225 Double (10'x20' booth)**

All application fees must be postmarked no later than Wednesday, September 1, 2010.

Any applications received after this date will be charged an additional \$25.00.

**Placement will be subject to the approval of the Forest Festival Steering Committee.**

**Vendors will be given a packet of materials the day of check in, detailing setup procedures, assignment map and take-down procedures.**

It is herein agreed by both parties that the Texas State Forest Festival will retain full control of the creation and sale of any item bearing the name of Texas State Forest Festival or Forest Festival. It is also agreed by both parties that:

- (A) Exhibitor must supply with the application 2 (two) pictures of their exhibit or product, as they will be displayed. Texas State Forest Festival has the right to refuse any exhibit deemed inappropriate for this event, and remove any offensive or inappropriate merchandise or displays.
- (B) **All paid exhibitors will be given two (2) five-day passes to enter the Festival. Additional five-day passes are \$10.00. YOU MUST BE RESPONSIBLE FOR SEEING THAT YOU OR YOUR BOOTH WORKERS HAVE NECESSARY PASSES – Please do not have workers show up at the front gate and request us to call you to get a ticket or pass into the event. Taking care of your workers is your responsibility!**
- (C) The number of spaces is limited. Spaces will be assigned by the Festival Committee and information will be available the day of set up, Wednesday, September 22 until 4:00 p.m..
- (D) Exhibitors are responsible for their own set up equipment, such as tables and chairs or whatever may be needed for their display. Exhibitor is responsible for his/her equipment in case of loss or damage.
- (E) Any exhibitor that sells a product must collect sales tax if they are not exempt and are responsible for reporting their own tax to the Texas State Comptroller.
- (F) Any "free" giveaway items must be listed and list attached to this agreement.

- (G) **No booth may give away nor sell food or drinks except as approved by the Forest Festival Steering Committee.** Forest Festival has the right to refuse any vendor.
- (H) Vendors failing to comply with all rules may be required to leave the show and forfeit all monies.
- (I) Booths cannot be shared or subleased. **No fees will be refunded after September 1, 2010!**
- (J) Exhibitions shall not block aisle with displays or persons promoting your booth. Exhibitors must keep demonstrations within assigned space.
- (K) The receipt of application and fee is commitment to show. Once accepted, **NO REFUNDS after September 1, 2010.**
- (L) Hours of Operation for the Forest Festival are as follows: Wednesday-Friday, 5:00 p.m. - 10:00 p.m., Saturday, 9:00 a.m.-10:00 p.m.. And Sunday, 11:00am- 5:00pm. **Booths must be set up and ready to open by 4:00 p.m. Wednesday, September 22, 2010. NO EXCEPTIONS!**
- (M) **Exhibitors will not be allowed to disassemble their booth until 5:00 p.m. Sunday, September 26, 2010.**

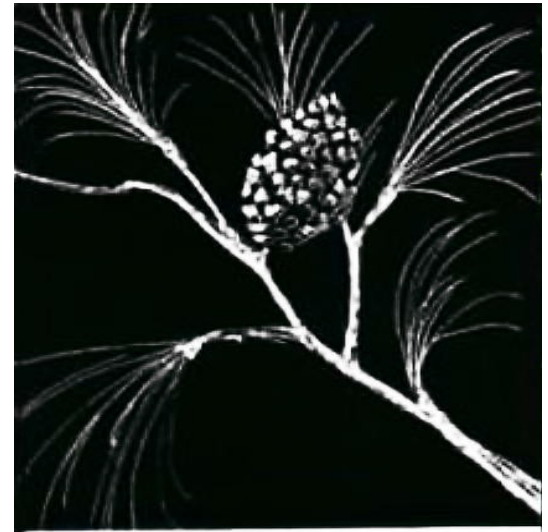
